Information Requested:

Can I please request the below data from the 1st march to the 7th April of patients with covid 19 diagnosis. (If this takes a while to be looked into, can I have data up to the day before you gather the data, as I wish to have the most up to date data)

Number of hospital admissions of covid 19 patients per date, split into hospitals.

Of those patients, per hospital, their ethnicity. (Total ethnicities is good per hospital rather than per day)

Number of hospital discharges.

Length of stay of those discharged. (Ie, 100 stayed 2 days, 400 stayed 10 days etc..) no requirement to break down per area, unless it is easier to complete this.

Number of autopsies completed of those who have died while having the covid 19 virus, split per hospital.

Information provided for the answer:

Thank you for your recent request. Public Health Wales does not hold the information requested, hospital admission data would be held by the individual health boards.
