I am writing to make an open government request for all the information to which I am entitled under the Freedom of Information Act 2000.

Please send me:

- A list of your in-patient mental health wards, including name of ward and address, and the area, such as CAMHS, Eating Disorders, Mother and Baby, Older adults, Acute
- Details of complementary therapies that are delivered to service users in your mental health hospitals/units.

-Which departments receive complementary therapy, such as AWA/CAMHS/Older adults?

-A list of complementary therapies that you offer, such as reflexology, massage, aromatherapy, acupuncture, yoga

-Do you employ complementary therapists?

-Who delivers complementary therapy in your hospitals, i.e (nursing staff/occupational therapist/complementary therapists)?

-Finally, how are complementary therapies funded in your hospitals? And at what cost?

I would like the above information to be provided to me as electronic copies, or an opportunity to view.
